## **OLD BUSINESS**

## APPROVAL OF MINUTES

3:33 pm Obadiah asked committee members to review the minutes from the March 18, 2022 CMAC meeting. Explained that the CMAC folder is in google docs, Cathy added the link to the chat. This folder is only accessible for CMAC members.

## Discussion: Are the April minutes phrased properly?

Current: Sonja moved to recommend a full adoption of the K-5 ELA Curriculum Into Reading published by Houghton Mifflin Harcourt for implementation in the fall of the 2022-2023 school year to replace all current core and supplemental reading and writing curriculum(s).

## Nancy Dodson seconded the motion; no opposed; motion carries.

Discussion on amending the 3/18/22 minutes: need to clarify which specific programs will be replaced, instead of stating "ALL current core and supplemental.... Curriculums".

K-5 ELA Presentation says "will replace all current core and supplemental reading and writing curriculum including Benchmark Literacy Reading and Writing Workshop, Words Their Way, and Teachers College Units of Study for Ready and Writing" and it was explained that saying the word "all" could be interpreted as everything existing currently for core and supplemental reading and writing curriculum.

After discussion, we have a motion to amend the March 2022 minutes:

Rebecca moves that we amend the minutes to read as, "a recommendation to adopt "Into Reading" by Houghton Mifflin Harcourt for implementation of the fall 2022-23 school year to replace Benchmark Literacy Reading and Writing Workshop, Words Their Way, and Teachers College Units of Study for Ready and Writing".

Rebecca motion, Kim seconded. Obadiah (OB) called for the question, the motion carried.

Nancy Dodson approved the March 2022 minutes as amended, and Greg Cox seconded. No opposed; the motion carries.

## **NEW BUSINESS- PRESENTATIONS FOR APPROVAL:**

#### Sonday Reading System

- Sponsored by Amity Butler/Director, Accelerated Models & Programs
  - Structured, systematic multisensory reading interventions for readers at the beginning stages of reading through 8<sup>th</sup> grade reading levels
    - District supplemental materials adoption
    - o Elementary and potentially middle school intervention
    - Intensive intervention
    - Sonday Systems 1 and 2 both support students identified as at-risk for dyslexia or diagnosed with dyslexia.
    - Pilot Process had 10 elementary schools in all four regions

- Staff- 2 days of 6 hour training (one for each system) before implementation
- Learned SS1 was too difficult for students who did not have solid grasp of letter sounds
- o iReady reading diagnostics provided data with improvements
- o All staff will need two days of 6-hour training
- Intervention schedules
- Funding total \$59,500
  - 35 Sets of System 1 and System 2: \$46,000
  - 4 days of training: \$13,500
  - Funding split between Title 1, Title 3 and LAP grants

Nancy Dodson: I move that we recommend we approve the Sonday System 1 and 2 as a district intervention curriculum for Grades K-5 with the potential for extending into MS, as a reading instruction for students below grade level to serve students with dyslexia.... Greg Cox seconded the motion.

All in favor, no opposed. Motion carries.

#### **Ethnic Studies Update**

Presented by Melissa Riley and Ayva Thomas

- Timeline
  - 2021-22 SY: complete NSD framework draft, draft high school course, OSPI Ethnic Studies Framework and Open Educational Resources
  - 2022-23 SY: pilot NSD framework, pilot HS course, community education and feedback, CMAC and school board for recommendation
  - Themes (draft): Identity, Power and Oppression, History of Resistance and Liberation, and Healing
- P-12 Framework Update
  - Enduring Understandings in a classroom environment is similar to weaving a basket (different components: every student is different with their own story; what content is taught, restorative justice and healing, etc.), and no two baskets will look exactly the same.
  - o Continuing the Ethnic Studies Work Team to pilot the framework
  - Focusing family and community members engaged members on the team
- Ethnic Studies HS Course Update
  - 8 mini units (18 weeks/semester) and want the students to develop understanding around: central ideas, relevant content, inquiry & choice, cross cutting concepts
  - Next Steps HS Pilot:
    offered in our 4 comprehensive HS

- Prioritize 1<sup>st</sup>, 2<sup>nd</sup> semester option
- Provide resources that are common across the course and expansive to support ranges
- Cross building PLC for teachers
- Shifting the cycle of feedback to amplify student voice
- o Context-embedded experiential learning and data gathering
- Resources
